### 5.3. Special protective actions for fire-fighters

### **SECTION 6: Accidental release measures**

### 6.1. Personal precautions, protective equipment and emergency procedures

Evacuate area. Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Use only non-sparking tools. Ventilate the area with fresh air. ### **6.2.** Environmental precautions

### 6.3. Methods and material for containment and cleaning up

If possible, seal leaking container. Contain spill. Cover spill area with a fire-extinguishing foam. ### 7.1. Precautions for safe handling

### 8.2. Exposure controls
