RECOMMENDED USES

Use on properly prepared wood, plaster, drywall, patching compound, wall repairs, tape joints, masonry, brick, plywood, wallpaper, ceiling tiles and painted surfaces. Limit exterior use to spot priming stains only. CONTROLZ™ is not intended as a whole house exterior primer.

APPLICATION AND CLEANUP

Stir thoroughly. Intermix containers to ensure uniform color. Apply with a premium-quality roller, polyester brush or airless sprayer. If applying spray, back-roll or back-brush to work into the surface. Apply a liberal coat of product uniformly, working well into the surface.

Tinting: To assist in dramatic, wall color changes, tint with up to 2 oz. per gallon of Universal Tinting Colorants to a shade similar to desired top coat. Clean up with warm, soapy water.

SURFACE PREPARATION

General:

Read the Lead Warning paragraph. Clean and dry surface thoroughly. Scrub stained areas with an all-purpose cleaner to remove any residual stains. Remove all surface dirt, chalk, peeling paint and mildew.

Stains:

Most stains can be sealed in one coat; however, stubborn stains may require additional coats. Always test first in a small hidden area to determine actual sealing results. Spot priming stubborn stains may be required.

Mildew Stains:

This product seals residual mildew stains, but will not resist active mildew growth. Active mildew must be removed prior to application by scrubbing area with a commercial mildew remover or a mix of 1 part liquid chlorine bleach to 3 parts water. Rinse thoroughly. Wear protective goggles and rubber gloves to avoid chemical contact with skin or eyes.

Previously Painted Surfaces:

Glossy paint needs to be dulled with a chemical deglosser or sanding.

New Wood Surfaces:

Spot prime wood knots and areas of tannin bleedthrough, once dry prime entire surface.

Metal:

This product is not for use over metal, but can be used over painted metal to seal light rust stains.
