SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

6.1.1. For non-emergency personnel

Protective equipment	: Avoid dust formation and breathing dust. Avoid contact with skin, eyes and clothing. Keep away from sources of ignition. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Wear recommended personal protective equipment.
Emergency procedures	: Do not breathe dust. Avoid contact with skin, eyes and clothing. Keep upwind. No flames, no sparks. Eliminate all sources of ignition.

6.1.2. For emergency responders

Protective equipment	: Do not attempt to take action without suitable protective equipment. Positive pressure self-contained breathing apparatus (SCBA). For further information refer to section 8: Exposure controls/personal protection.
Emergency procedures	: Use grounded electrical/mechanical equipment. Contain spill and monitor for excessive dust accumulation. Turn off electric power to area. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). As an immediate precautionary measure, isolate spill or leak area for at least 50 meters (150 feet) in all directions. Evacuate unnecessary personnel.

6.3. Methods and material for containment and cleaning up

Methods for cleaning up	: Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Sweep or scoop spills, dispose of any unusable material in approved landfill. Non-sparking tools should be used. All equipment used when handling the product must be grounded. Wear appropriate personal protective equipment, avoid direct contact.

7.1. Precautions for safe handling

- Precautions for safe handling : Ensure good ventilation of the work station. Avoid dust formation. Do not handle until all safety precautions have been read and understood.
