PRODUCT DESCRIPTION

DURAPRO AF0036 is a non-flammable interior flooring adhesive for bonding carpet and sheet covering over plywood underlayment or well cured concrete.

PRODUCT FEATURES

PREPARATION

Subfloors must be structurally sound, linear, porous, clean, dry and free of contaminants. Adhesive and flooring (unwrapped) must be at room temperature (20°C) 24 hours before, during, and after installation. Concrete floors must be fully cured and free from moisture and hydrostatic pressure..

APPLICATION

Stir before using. Spread adhesive with a 2 mm (1/16'') V notch trowel held at 45° angle for smooth backing. For floor covering with rough backing use a 5 mm (3/16'') V notch trowel. Spread the adhesive and put the floor covering in place within 30 minutes. Lay the flooring material as per manufacturer's instructions. Use a 45 kg (100 lbs) roller in several directions to eliminate trowel marks and air entrapment, and to ensure optimal transfer of the adhesive. Let dry 24 hours before allowing heavy foot traffic or moving furniture.

COVERAGE

Approximatively 2-4 m²/L (80-160 sq.ft./gallon)

ATTENTION

Refer to flooring manufacturer's recommendation for layout, expansion space requirements, and detailed installation instructions. For indoor use only. Not to be used on particleboard.

CLEAN UP

Clean hands, tools and excess adhesive with warm soapy water before the product dries. If glue has hardened, use a putty knife and mineral spirits with caution, taking care not to affect the surface finish.

STORAGE

Shelf life is 18 months at room temperature in original unopened container. Product is freeze/thaw stable if frozen not lower than -10° C.
