PRODUCT DESCRIPTION

DURA PRO AF 0034 is a high solids latex based adhesive used for direct glue-down of pre-finished 12"x12" finger strips parquet made of maple, oak or birch on T&G floor grade plywood or cured concrete either on above or below grade.

PRODUCT FEATURES

PREPARATION

Subfloors must be structurally sound, linear, porous, clean, dry and free of contaminants. Adhesive and wood flooring (unwrapped) must be at room temperature (20°C) 24 hours before, during, and after installation. Best bonds are obtained when moisture content of wood ranges between 8% and 12%; concrete floors must be fully cured and free from moisture and hydrostatic pressure.

APPLICATION

Stir before using. Spread adhesive with a 5 mm (3/16") V notch trowel held at 45° angle. Apply adhesive evenly on surface which can be covered in about 10 minutes. Leave 6 mm (1/4") minimum space uncovered along the walls and permanent structures for normal wood expansion. Install the parquet then press it down into the glue by using a rubber mallet or walking on it in both directions step by step. Check for adhesive transfer to the back of the parquet. Let dry 24 hours before allowing heavy foot traffic or moving furniture.

COVERAGE

Approximatively 2 m²/L (80 sq.ft./gallon)

ATTENTION

Refer to wood flooring manufacturer's recommendation for layout, expansion space requirements, and detailed installation instructions. Room temperature must be kept at 20°C and at relative humidity between 35%-55% one week before the installation and thereafter. For indoor use only. For basement floors or areas below grade, a subfloor should be built over a vapour barrier.

RESTRICTIONS

AF 0034 is not recommended for engineered wood flooring, wood planks, and exotic woods. Not to be used on particleboard.

CLEAN UP

Clean hands, tools and excess adhesive with warm soapy water before the product dries. If glue has hardened, mineral spirits may be used with caution for cleaning. On bonded materials, scrape off and sand dried excess.

STORAGE

Shelf life is 18 months at room temperature in original unopened container. Product is freeze/thaw stable if frozen not lower than -10°C.

PRECAUTIONS
