SECTION 4 – FIRST AID MEASURES

Signs and symptoms of short-term (acute) exposure

- Inhalation* : Symptoms may include coughing, wheezing, shortness of breath, burning sensation in nose or throat, and fluid accumulation in lungs (pulmonary edema). Inhaling large amounts may cause drowsiness, dizziness, or loss of coordination.
- Skin* : Causes skin burns. Symptoms may include redness, itching, and pain. Some components may be absorbed through the skin.
- Eyes* : Causes eye burns. Symptoms may include redness, itching, and pain. May cause blindness if not treated promptly.
- Ingestion* : Causes burns to the mouth, throat, and digestive tract. Symptoms such as gastric pain, nausea, vomiting, and diarrhea may occur. Ingesting large amounts may cause drowsiness, dizziness, or loss of coordination.

Effects of long-term (chronic) exposure

SECTION 5 – FIRE FIGHTING MEASURES
