PRODUCT APPLICATION

Note: Do not mix with any other chemicals. For best results, treat stains immediately and do not over saturate carpet. Some stains will cause permanent discoloration even after cleaning.

PRODUCT APPLICATION**DIRECTIONS**

Always test on an inconspicuous area for colorfastness. Remove any excess solids or liquids. Turn nozzle to spray position. Spray 6-8" from the surface and allow to sit 5 minutes. Blot with a clean, absorbent and color-fast cloth and allow area to dry completely. For tough stains, scrub gently with a brush and repeat as necessary.

FIRST AID: In case of contact with eyes or skin, flush with water for at least 15 minutes and consult a physician. If on skin, wash off immediately with soap and plenty of water. If inhaled, move to fresh air. If swallowed, clean mouth with water and afterwards drink plenty of water. **Do not induce vomiting.** Get medical attention.
