4. First-Aid Measures

6. Accidental Release Measures

PERSONAL PROTECTION

10. Stability and Reactivity

CONDITIONS TO AVOID: Avoid contact with strong acid and strong bases.

INCOMPATIBILITY: Avoid contact with water. Incompatible with strong oxidizing agents, strong acids and strong alkalies.

HAZARDOUS DECOMPOSITION: When heated to decomposition, it emits acrid smoke and irritating fumes.

11. Toxicological Information

EFFECTS OF OVEREXPOSURE - EYE CONTACT: May cause eye irritation. Irritating, and may injure eye tissue if not removed promptly.

EFFECTS OF OVEREXPOSURE - SKIN CONTACT: May cause severe irritation. May cause dryness, cracking, irritation, and chemical burns. May produce cement dermatitis due to primary irritation from alkaline, hygroscopic, and abrasive properties. Low hazard for usual industrial handling or commercial handling by trained personnel.

EFFECTS OF OVEREXPOSURE - INHALATION: Avoid breathing fumes, spray, vapors, or mist. High gas, vapor, mist or dust concentrations may be harmful if inhaled.

EFFECTS OF OVEREXPOSURE - INGESTION: May cause obstruction in stomach, as it hardens with moisture. Symptoms include stomach pain, distress. Drinking glycerin, gelatin solutions, or large volumes of water may delay the hardening of calcium sulfate in the stomach. Surgical relief of obstruction, particularly at the pylorus, may be necessary. Expected to be a low ingestion hazard.

EFFECTS OF OVEREXPOSURE - CHRONIC HAZARDS: Contains Titanium Dioxide. Titanium Dioxide is listed as a Group 2B-"Possibly carcinogenic to humans" by IARC. No significant exposure to Titanium Dioxide is thought to occur during the use of products in which Titanium Dioxide is bound to other materials, such as in paints during brush application or drying. Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of Titanium Dioxide in the formula.
