Section 5. Fire-fighting measures

Precautions for safe handling

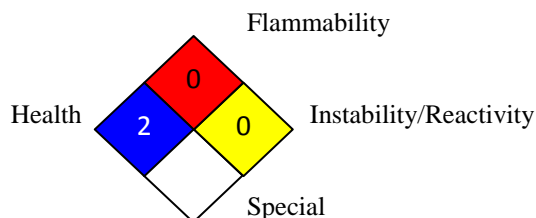
