USES:

Roberts 2038 is a non-flammable, environmentally friendly, rubber-asphalt emulsion adhesive designed to adhere vinyl composition tile (VCT) to plywood of underlayment quality, terrazzo, marble, sound-resilient floors, which are free of wax and embossing, and on-, above-and below-grade concrete subfloors. It is solvent-free, virtually odourless and sets to a highly tacky film and provides a superior permanent bond. Designed for indoor use only.

Rated: Commercial or Residential

CONDITIONS AND LIMITATIONS:

- Temperature: Adhesive and floor must be at least 65° F (18.3°C), or higher at the time of the installation, and maintained for up to seven days after the installation.
- Condition of floor: Clean, sound, dry and free of hydrostatic pressure, alkali, oil, dust, dirt, moisture, grease and wax. All substrate cracks, joints and uneven areas shall be filled with a Portland cement-based patch.
- Roberts does not recommend tile to be installed on concrete emitting over 5 pounds moisture or higher and alkaline floors measuring 10 or above.
- 4. Use only to install reinforced vinyl floor tiles(VCT).
- Shelf life is one year from date of manufacture.
- 5. DO NOT FREEZE!
- Drying Time: Restrict foot traffic and moving of heavy objects for 24hrs.
 Do not expose to water for 4-days.
- Do not clean (standing water), strip, seal or wax the new tile floor for up to 7 days following the installation.

High-tack asphalt-emulsion adhesive for vinyl composition tiles (VCT)

PREPARATION & APPLICATION:

- Lay out material according to manufacturer's specifications.
- Apply adhesive with a 1/16" x 1/16" x 1/16" V-Notched or 1/16" x 1/32" x1/32" U-Notch trowel.
- Set the tile into the adhesive when it is tacky to the touch and is dry, normally within 45 – 60 minutes after spreading adhesive onto the subfloor. If, necessary, reposition the tile before the adhesive sets.
- Roll tiles immediately after application with a 100-lb. 3section roller (Roberts 10-952).

VENTILATION: To enhance curing of adhesive, implement effective ventilation by opening windows and doors for an adequate supply of fresh air. Also, consider using window fans and/or air movers to bring fresh air in and to exhaust emissions to the outdoors.

CLEAN UP:

Wet adhesive can be cleaned from tools and flooring with warm soapy water using a clean white cotton cloth. Roberts 1912 Adhesive Cleaner should be used to remove dried adhesive from top surface of tile using a clean white cotton cloth. Do not pour cleaner directly onto tile.

TOOLS AND MATERIALS RECOMMENDED:

- 1. Trowel (See Coverage chart)
- 2. Roller-100-lb. or use tile manufacturer's recommendation.
- 3. Vinyl Tile Cutter.
- 4. Chalk Line and/or marker.
- 5. Cleaner (Roberts 1912)
