### **Specific Hazards Arising from the Product**

## Personal Precautions, Protective Equipment, and Emergency Procedures

No special precautions are necessary.

### Environmental Precautions

Do not allow into any sewer, on the ground or into any waterway.

### Methods and Materials for Containment and Cleaning Up

Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13). Use spark-proof tools and explosion-proof equipment. Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product. ## SECTION 7. HANDLING AND STORAGE

### Precautions for Safe Handling
