Precautions for safe handling

Appropriate engineering controls

- : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.

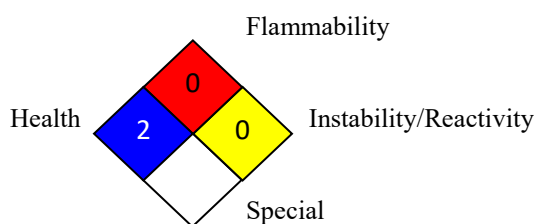
