**Mixture Description** : Highly refined mineral oils and additives.

**3. HAZARDS IDENTIFICATION**

**WHMIS Class/Description** : THIS PRODUCT IS NOT A WHMIS CONTROLLED SUBSTANCE.

**Routes of Exposure** : Skin and eye contact are the primary routes of exposure although exposure may occur following accidental ingestion.

**Health Hazards** : Not expected to be a health hazard when used under normal conditions. Prolonged or repeated skin contact without proper cleaning can clog the pores of the skin resulting in disorders such as oil acne/folliculitis. Used oil may contain harmful impurities.

**Signs and Symptoms** : Oil acne/folliculitis signs and symptoms may include formation of black pustules and spots on the skin of exposed areas. Ingestion may result in nausea, vomiting and/or diarrhoea.

**Safety Hazards** : Not classified as flammable but will burn.

**4. FIRST AID MEASURES**

**7. HANDLING AND STORAGE**

- General Precautions** : Use local exhaust ventilation if there is risk of inhalation of vapours, mists or aerosols. - Exposure Controls** : The level of protection and types of controls necessary will vary depending upon potential exposure conditions. Select controls based on a risk assessment of local circumstances. Appropriate measures include: Adequate ventilation to control airborne concentrations. - suitable gloves offering this level of protection may not be available and in this case a lower breakthrough time may be acceptable so long as appropriate maintenance and replacement regimes are followed. Glove thickness is not a good predictor of glove resistance to a chemical as it is dependent on the exact composition of the glove material.
- Eye Protection** : Wear safety glasses or full face shield if splashes are likely to occur.
- Protective Clothing** : Skin protection not ordinarily required beyond standard issue work clothes.
- Monitoring Methods** : Monitoring of the concentration of substances in the breathing zone of workers or in the general workplace may be required to confirm compliance with an OEL and adequacy of exposure controls. - Acute Toxicity** : Poorly soluble mixture. May cause physical fouling of aquatic organisms. Expected to be practically non toxic: LL/EL/IL50 > 100 mg/l (to aquatic organisms) LL/EL50 expressed as the nominal amount of product required to prepare aqueous test extract. Mineral oil is not expected to cause any chronic effects to aquatic organisms at concentrations less than 1 mg/l.
- Mobility** : Liquid under most environmental conditions. If it enters soil, it will adsorb to soil particles and will not be mobile. Floats on water.
