Mosquito Octenol Replacement Lure

FIRST AID	
If on skin or clothing	Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.
If in eyes	Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.
If inhaled	 Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.
If swallowed	 Call poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vorniting unless told to do so by the poison control center or doctor. Do not inve anything by mouth to an unconscious person.

- 1. Peel foil cover and snap into the built-in holder at the bottom of the Stinger Insect Zapper.
- For other insect zappers call 800-477-0457 and we will send you a small cassette to attach to the outer enclosure.
- 3. Place a reminder sticker on your calendar and replace lure after 30 days.

STORAGE AND DISPOSAL

Cartridge Storage: Store this product in a cool, dry place out of the reach of children until ready to use.

Cartridge Disposal: Nonrefillable container. Do not reuse or refill attractant cartridge.

Dispose of used attractant cartridge in the trash or offer for recycling if available.
