## Block Invading Mice with Mouse Shield™

Mouse Shield contains an EPA-registered pesticide that protects the foam from attack by mice, birds, bats and tree squirrels. It also blocks ants, roaches, spiders and bees. Use Mouse Shield to fill gaps and cracks inside your garage, attic, crawl space, basement, under sinks, around pipe/electrical penetrations or any areas where pests, insects or drafts can enter your home and living spaces.

### Mouse Shield Product Benefits:

- Contains EPA-registered pesticide that protects foam from attack by mice and other pests.
- Safe to use and contains no lingering odor.
- Air seals and insulates to save on energy costs.
- Tack-free in 15 minutes and dries in 4 hours.



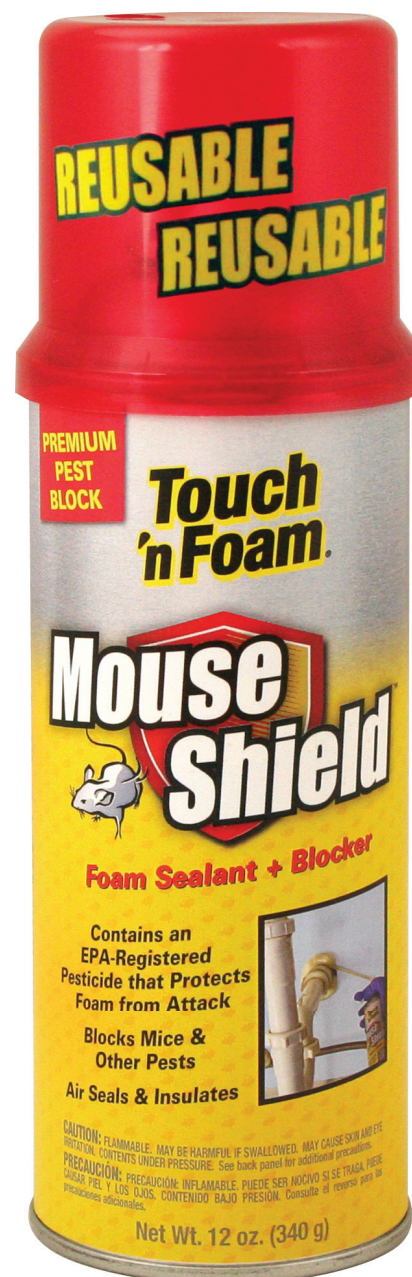
### How to Apply:

- Connect straw onto angle adapter, then carefully screw onto valve.
- Shake can vigorously for 30 seconds.
- First practice dispensing foam onto scrap materials with the can in an upright position. The product is now ready to be applied while holding the can in any direction.
- For best results, apply in temperatures between 60° and 100°F.
- Fill gap no more than 1/3 full, allowing room for expansion.



### Reusable:

To store unused portion, bend straw back and attach to the knob atop the dispensing trigger. Store upright below 90°F (33°C). Product can be reused within three weeks if stored properly. To reuse, cut the end off the straw (removing any cured foam), shake well and apply as directed.

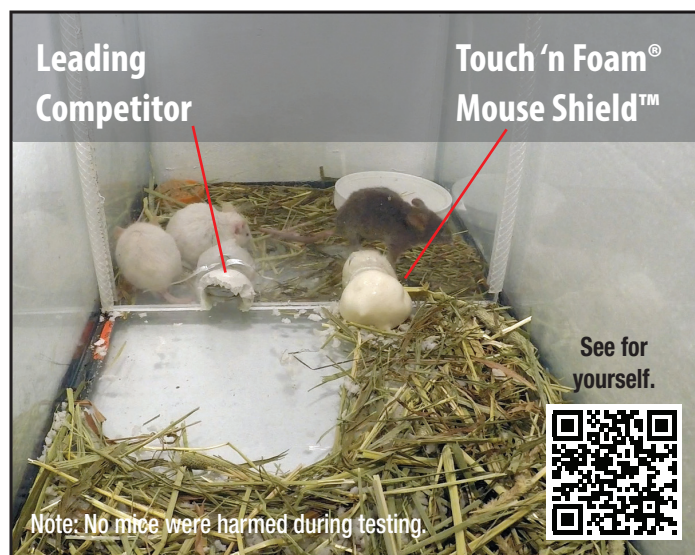

### PRODUCT FAQ's

#### Does Mouse Shield kill mice?

No. Testing shows mice avoid treated foam.

#### Is it safe for people and pets?

Mouse Shield is safe for use around people and pets, but caution should be used when spraying foam sealants.

#### Will it work on other pests?

Mouse Shield effectively blocks birds, bats, tree squirrels as well as ants, roaches, spiders and bees.

#### Don't regular foam sealants block pests?

Most foam sealants block pests, however, testing shows that mice can chew through foam not treated with a special ingredient.

#### Does Mouse Shield's effectiveness wear out over time?

Testing has shown that the potency of the EPA-registered pesticide in Mouse Shield will slightly wear down over time, however, it will still remain effective in blocking mice and other pests. Should a pest choose to bite or tear into the foam, the cellular structure will release odor when opened.

#### Will painting over the foam affect product performance?

Painting the foam will affect the potency of the product, but not enough for mice to chew through it. Should a mouse try to scratch or bite the foam, the cells within the foam will release odor.
