Previously Painted/Stained Concrete: Clean with an all-purpose cleaner (TSP or substitute). Previously sealed surfaces must be porous and able to accept additional sealer. Test surface porosity before sealing: Avoid using this product on nonporous, sealed surfaces. To test, place a few drops of water on the surface. If water sinks in, the surface is porous enough to use this finish. If water remains on the surface, do not use.

APPLICATION

Use a roller or low-pressure garden type sprayer. While the first coat is still wet, apply a second coat to maximize protection. Allow 5-10 minutes for final penetration, then use a clean, dry cloth to wipe off all excess which did not soak into the surface. Do not pond or puddle this product.

Periodic maintenance: Reapply when water begins to penetrate the surface again.
