## INSULATING COVERS FOR H-TAP AND C-TAP CONNECTORS



### Catalog Numbers:

HTCV1, HTCV2, HTCV3, and HTCV4

**Material:** Polypropylene

**Temperature Rating:** 105°C Max.

**Voltage Rating:** 600 Volts Max.



### WARNING

- Never attempt to apply cover to a "HOT" line.
- Wear safety glasses.
- Keep fingers away from locking latches, could cause pinching.

### Installing Instructions:

- 1) Install cables in connectors (per instructions supplied with connectors).
- 2) Remove all burrs and sharp edges after the crimping process has been made.
- 3) Uninsulated end of cable should not protrude more than 1/4" beyond connector.
- 4) Place connector between inner ribs (See Figure 1).
- 5) Close cover making sure the locking latches are fully engaged (See Figure 2).

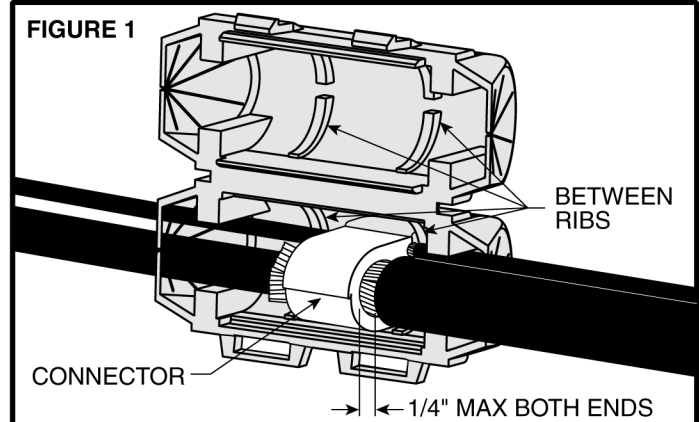
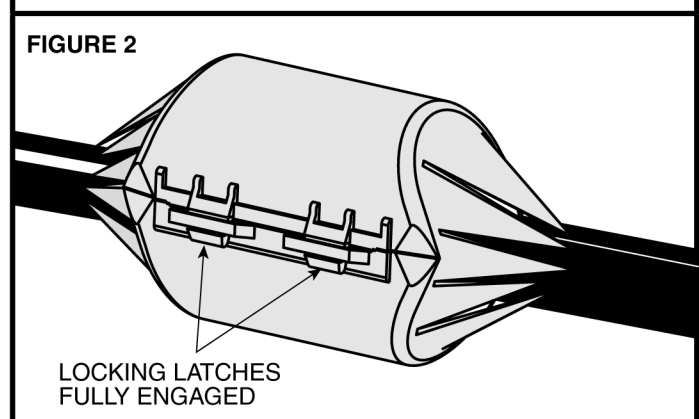
