

FIXED TYPE CLAMP STYLE 1



1. Remove any non conductive coating from surface of conduit at clamp contact points prior to installation.
2. Assemble clamp to lip of tray, insert conduit; then tighten hex nuts per UL467*.
3. Tighten grounding screws on saddle.

SWIVEL TYPE CLAMP STYLE 2



1. Remove any non conductive coating from surface of conduit clamp.
2. Assemble mounting bracket to lip of tray and tighten grounding screws per UL467*.
3. Position U-Bolt at proper angle to accept conduit. Insert conduit, and tighten hex bolt per UL467*.

*According to UL467, tightening torque shall be 150 pound-inches applied to each clamping bolt or screw, except that a torque of 50 pound-inches shall be applied to a clamping screw intended to be tightened only with a screw driver.

APPLICATION

- For Aluminum or Steel Tray with regular or reinforcing ribs.

FINISH

- Zinc Plate.
